**SCHOOLCHILDREN'S AFTERNOON ACTIVITIES AT PLAY PARKS**

Play parks provide schoolchildren with a diverse and inspiring environment for spending free time after school. In the afternoon activities for schoolchildren, the children have the opportunity play freely, engage in physical activities, play games, spend time outdoors, meet friends, relax and take part in guided activities both indoors and outdoors. Instructors will ensure the children's safety during the afternoon. The children are covered by insurance when in the play park.

The registration form must be taken in person to the play park where the child is to be attending the afternoon activities.

**Registration period: 23 March–24 April 2020**

Notification about the place in the afternoon activities will be sent to the parents/guardians by post by 1 June 2018. You can also register for the afternoon activities at play parks mid-season.

The afternoon activities at play parks are free of charge. Children may also be registered for snacks at the play park for €36.10/month or bring their own snacks with them. An exemption from the fee for snacks is possible. In autumn 2020, operations at some playgrounds will change to basic education group-based after-school activities subject to a fee.
