

## Accessibility statement

This accessibility statement applies to the Helsinki Energy Challenge website of the City of Helsinki. The website's address is <https://energychallenge.hel.fi/>.

### Legislation applicable to the website

This website was published after 23 September 2018. The website must comply with the accessibility requirements as required by law.

### The City's objective

Regarding the City's digital services, the City's objective is to achieve the AA level or higher as defined in the Web Content Accessibility Guidelines, as far as reasonably possible.

### Compliance status

This website complies with the critical accessibility requirements at the AA level of WCAG 2.1 but includes the following deficiencies:

### Inaccessible content

The content specified below does not comply with all the accessibility requirements set by the law.

### Observed deficiencies

- The site has buttons that have been implemented inadequately. (4.1.2 Name, Role, Value)
- The site has PDF files that have inadequate language settings. (3.1.1 Language of Page)
- The site has content that has not been assigned an appropriate lang attribute. (3.1.2 Language of Parts)
- The site contains inadequately described links. (2.4.4 Link Purpose (In Context))
- The site has interactive elements that cannot be focused on by keyboard. (2.1.1 Keyboard)
- The site's jump link does not work as intended. (2.4.1 Bypass Blocks)
- The site's elements have been designed with HTML marks. (1.3.1 Info and Relationships)
- Some of the embedded elements on the site are missing the title determination. (4.1.2 Name, Role, Value)
- The site has some deficiencies related to contrast. There is insufficient contrast between the text and the background of some elements. (1.4.3 Contrast (Minimum))

### Correction of deficiencies

We will attempt to correct the deficiencies observed so that the website can be used both by keyboard and assistive technologies. The corrective measures require that the operating principles of the current publication system are changed, and this will affect all websites using the same system. Corrections will be made in connection with a system update. The website is temporary and will close in 2021.

### Accessibility assessment

The accessibility assessment complies with the guidelines of the City of Helsinki and methods that aim to ensure the accessibility of the website at all stages.

Accessibility has been verified through an audit performed by an external specialist and through self-assessment.

Accessibility has been verified using a programmatic accessibility verification and manual inspection of the website and content. The programmatic verification has been carried out using the Siteimprove automatic accessibility testing tool and browser extension.

The accessibility of the website will be maintained through constant supervision as the technology or content change, as well as through regular inspections. This statement will be updated in connection with the changes to the website and as accessibility is inspected.
