Participation in ethics and religion studies

Participation in ethics and religion studies Pupils belonging to other religious communities **or** pupils who do not belong to any religious communities can **always** take part in the majority religion's teaching upon their guardian's request. The majority religion taught in the City of Helsinki is Evangelical Lutheran religion.

- The members of Evangelical Lutheran community will always take part in Evangelical Lutheran education.
- Members of the Orthodox community either participate in Orthodox studies or study with the majority.
- Pupils who are not members of any religious community study ethics (life stance education).
- All pupils can take part in the majority religion's education, Evangelical Lutheran education, if they so wish and upon their guardian's request.

Teaching for pupils' **own religion** will be arranged for pupils belonging to **another**, registered religious community than the Evangelical Lutheran church or Orthodox church who do not take part in the majority religion teaching (Evangelical Lutheran), upon their guardian's request. The pupils must be members of this religious community or the religion taught to the pupil must, in view of their upbringing and cultural background, evidently correspond to their religious beliefs (Basic Education Act, section 13, subsection 6). If necessary, the school can request that the pupil's guardian submit a reliable statement of the pupil's membership of the religious community or the way the pupil's upbringing and cultural background correspond to the religion taught to them. Religious education that is not yet available in the schools of the City of Helsinki will be started if there are at least three pupils in Helsinki who are members of the registered religious community, upon the request of their guardians.

- Teaching of Catholic, Islamic, Buddhist and Krishna-focused religious studies is offered regularly in Helsinki. The teaching location is usually the pupil's own school, even though the teaching is implemented in religion-specific class groups as regional education. The teaching follows the curriculum. The curriculums of a pupils' own religion studies for grades 1–9 are available online at: ops.edu.hel.fi
- Upon the guardian's request, pupils can take part in the teaching of their own religion by filling in this **Participation in the teaching of pupil's own religion** form.
- If the pupil will not take part in the majority religion or ethics teaching and if the pupil's religion or ethics studies are not taught at the schools of the education provider, other teaching or guided activities will be arranged for the pupil.
- Instead of participating in the other teaching or guided activities arranged by the school, the pupil can take part in teaching provided by their own religious community. A guardian must submit to the school a statement of the pupil's membership of the religious community in question and their participation in teaching provided outside of school. Any grade received from this teaching provided by a religious community will **not** be included on the school report card.

As with other studies, the choices and decisions made pertaining to religion and ethics education are permanent and cannot be changed. However, if the pupil's religious community changes or if the pupil is no longer part of any religious community, the pupil's guardian has the right to change their choices. Any changes are carried out once per school year.
