## **4. Purposes of the processing of personal data and the legal grounds for the processing**

### **Purposes of the processing**

The purpose of processing personal data is to enable traffic management activities and transport-related research and development activities in the Smart Junction project area in Jätkäsaari, Helsinki. The video footage collected will be used for traffic planning and research, traffic management and the production of traffic metrics such as vehicle numbers and types, queuing and the movements of road users.

### **Legal grounds for the processing**

Point (e) of Article 6(1) of the EU General Data Protection Regulation: Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller. The more specific grounds for processing are set out in Section 4(2) of the Data Protection Act (1050/2018); processing is necessary and proportionate for the performance of a task carried out in the public interest by a public authority.

## **5. Data content of the register**

The register contains video footage of public areas in Jätkäsaari, from which people and vehicle registration numbers can be identified.

## **6. Regular disclosures of personal data**

The data is not statutorily disclosed.

Data may be disclosed to the authorities entitled to receive it.

Data may be disclosed for research purposes or for a similar purpose under data protection legislation through a separate authorisation procedure.

Data in the register is not transferred outside of the EU or EEA.

## **7. Data storage periods**

The images transmitted by the cameras are real-time and not stored by default. If a camera image is recorded, the data is stored for the duration of the activity related to the recording (for example research), but no more than for the duration of the project, i.e. three years, after which the data will be deleted.

## **8. Sources of personal data**

The personal data is collected from cameras located in the Smart Junction project area in Jätkäsaari, Helsinki.
